On our brand new development, The Blossoms, we have a limited selection of homes that are available through the **Standard Shared Ownership Model** and are **restricted** to a **local connection criteria**.

### What does this mean?

The Shared Ownership Model decides the maximum and minimum share you can purchase. The Standard Shared Ownership Model allows you to purchase between **25%-75%**, where as the new model allows you to purchase between 10%-75%.

### What is the local connection criteria?

To be eligible to purchase the above plots, you will need to have a connection to Crewe either through family, employment, residency or being a member of the Armed Forces – for details speak to the Sales Team.

## Key information about the home

- where the home is located
- whether the home is for a specific group of people

When you are looking for shared ownership homes, you should always check the Key Information Document to see which model covers that specific home.

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should take independent legal and financial advice.

This key information document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference. This document 'Key information about the home' is a summary and you should consider the information in 'Summary of costs' and 'Guide to shared ownership' before making a decision.

This does not form part of the lease. You should carefully consider the information and the accompanying lease and discuss any issues with your legal adviser before signing the lease.

Failure to pay your rent, service charge, or mortgage could mean your home is at risk of repossession.
